TAX-NEUTRAL SCHOOL REFERENDUM

On Tuesday, January 26, 2016, the Readington Township community will be asked to vote on a tax-neutral referendum that will allow the school district to borrow an amount not to exceed \$1,780,000 to pay the cost of parking lot improvements at Readington Middle School and Holland Brook School, stairway reconstruction at Readington Middle School, and stairway reconstruction at Three Bridges School.

Passage of this referendum allows the district to access approximately \$569,000 in state aid to offset construction costs. This nearly 32% savings would be returned to the district's Capital Reserves account to fund future projects. No taxes will be raised as a result of this referendum.

Readington Township School District has the necessary funds already in the Capital Reserve account to pay for the proposed construction projects. Several projects are proposed for completion by September 2016. These include:

Holland Brook School

Parking Lot and Driveway Repaying \$990,000

The driveway leading from Readington Road to Holland Brook School has been in need of repair for several years. Patching has occurred as a temporary fix, but a complete repaving is necessary to prevent pothole craters from expanding.

Readington Middle School

Step Reconstruction\$121,600Parking Lot Repaying\$548,000

The side parking lot at RMS will be expanded to accommodate our fleet of school buses. Currently, the buses are parked on the front lawn of the school in an area of mud and loose gravel, a combination which erodes the underside of our buses. Expanding the lot on the east side of the middle school will allow the buses to be parked on blacktop in a more secure location on campus. Improvements to the new parking area will include new lighting, electrical outlets for bus block heaters, and new landscaping.

The student entrance to Readington Middle School is in need of repair. A section of the staircase has crumbled, requiring the temporary fix of a metal plate. The same crumbling and separating of concrete is now occurring on other steps in this entrance, requiring a total replacement of the stairway. This is a safety issue for our students and staff and requires immediate attention.

Three Bridges School

Stair Reconstruction

\$120,000

The stairway exits for the Media Center and Nurse's Office at Three Bridges School have eroded to the point where they are unsafe. Repeated freezing of water on the stairs has resulted in crumbling concrete and an unstable stepping surface. A full repair of these stairs will include redesign and replacement of the steps and landing areas, along with new safety railings and handrails. The repairs and improvements will bring these fire exits up to date with current ADA standards for accessibility.

TOTAL PROJECT COSTS:

\$1,779,600

Estimated State Debt Service Aid \$569,000 (This is estimated at nearly 32% of the project cost.)

Total Cost with Successful Referendum \$1,210,600

PARCC DATA

A presentation of the district's 2014-15 Assessment Results was reviewed at the December 8th Board of Education meeting. Individual student scores were received last week and are being mailed; families may expect to receive them by December 22. Parents with high school students may have received results earlier as high schools received data earlier than elementary and middle schools.

PARCC results will also be reviewed at the January 13th Home and School Business Meeting. The PARCC assessment was new to teachers and students last year and the student score information is also presented in a new manner. Parents are encouraged to contact their child's principal for any questions they may have regarding this assessment, or any aspect of their child's school experience.
