Superintendent's Report

Dr. Hart presented the progress made on the District Goals and Strategic Plan for the 2020-2021 school year. Dr. Hart and Mr. Bohm shared the New Jersey Quality Single Accountability Continuum (NJQSAC) results designating the district as high performing. Dr. Hart announced that the final 2021-2022 Budget and a revised 2020-2021 District Calendar would be approved at tonight's meeting. Schools will now be closed on May 28. - The board accepted the New Jersey Department of Agriculture's (NJDA) audit report and approved the certification and implementation of the corrective action plan.
