Superintendent's Report

- ◆ Dr. DeFabiis reported that there were no HIB incidents to report.
- ◆ The 2017-2018 Governor's Educator of the Year award honorees and this year's retirees were recognized.

Finance/Facilities

- ◆ Tuition contracts were approved for non-resident staff members' children to attend Readington Township Schools for the 2018-2019 school year.
- ◆ Resolutions for participation in joint transportation services for the 2018-2019 school year with The Somerset County Educational Services Commission and The Hunterdon County Educational Services Commission were adopted.
- ◆ A Shared Services Agreement for transportation services with Branchburg Township School District was approved.
- ◆ An agreement with Maschio's Trucking, LLC was approved to provide temperature controlled delivery services for the 2018-2019 school year.

Education /Technology

- ◆ Curricula were adopted for the 2018-2019 school year.
- ◆ The following field trips were approved: Branchburg Sports Complex (HBS Grade 5) and Hionis Greenhouses (RMS/HBS/WHS Life Skills Classes).
- ◆ The following RMS fundraisers were approved to benefit the Music Department: Scrip Gift Cards, Showcase of Music, and Birthday/Holiday Grams.
- ◆ Social Studies textbooks for Grades 6 and 8 were accepted.
