Superintendent Report

Administrative Reports

- The December Enrollment Drill Report was approved.
- The board accepted the HIB report and affirmed the Superintendent's decision.

Finance/Facilities

- The district bill list was approved.
- The district travel schedule was approved.
- The board ratified and accepted the Superintendent's recommendation to sever the Tewksbury IT Shared Services contract.
- The board approved the joining of the Bergen County Cooperative purchasing alliance to access service and product bids.
- The board approved the purchase of electric generation services through the Alliance for Competitive Energy Services (ACES).
- The board approved the purchase of natural gas services through the Alliance for Competitive Energy Services (ACES).
- The anonymous donation of \$2,000 to be applied to negative student lunch balances was approved.
- The Professional Services Contract with Settembrino Architects for the following projects was approved: RMS Roof Project, K-5 Elementary Schools Bathroom Project, and Ancillary fees/reimbursables.
- The following capital projects and an amendment to the district's Long Range Facility
 Plan were approved: RMS Partial Roof Replacement/HVAC Replacement, HBS New Single

- Occupancy Toilet Room, TBS New Single Occupancy Toliet Room, and WHS New Single Occupancy Toliet Room.
- The board authorizes the Business Administrator to solicit proposals for solar expansion.

Education/Technology

- Additional field trips were approved at Readington Middle School.
- The implementation of a Behavior Disabilities Program at Three Bridges School was approved to begin on February 1, 2023.
- Divonna Stebick was approved to facilitate Teacher Inquiry and Data as Tools to Examine Learning Gaps on March 16-17, 2023.
- Judy Lo Bianco, HPE Solutions Consultant, was approved to provide professional development training for the PE/Health staff on the District In-Service Day, March 17, 2023.
