The Board Goals were reviewed, and changes were discussed that would be made to the final document for approval at the November 15, 2022, Board of Education meeting.

### **Administrative Reports**

- The September Enrollment and Drill Report was approved.
- The District Goals for the 2022-2023 school year were approved.

### **Finance and Facilities**

- The district bill list was approved.
- The district travel schedule was approved.
- A resolution authorizing the disposal of surplus property was approved.
- The Uniform State Memorandum of Agreement between Education and Law Enforcement Officials for the 2022-2023 school year was approved.
- The board approved Settembrino Architect to conduct a feasibility study inclusive of a financial analysis for a solar array expansion project through a power purchase agreement. The Business Administrator with Settembrino Architects is approved to amend the district's long-range facility plan as filed with the State of New Jersey to include a solar expansion project.
- A parental transportation contract not to exceed \$20,000 pending approval of the Executive County Superintendent for the 2022-2023 school year was approved.
- The 2022-2023 M-1 and Comprehensive Maintenance Plan were approved.
