PROGRAM RECOGNITION AWARD READINGTON HOME SCHOOL ASSOCIATION

CRITERIA GUIDELINES

ELIGIBILITY REQUIREMENTS

- 1. The program must be currently recognized by the Readington Board of Education.
- 2. The program must be held on the premises of one of the four schools Readington Middle School, Holland Brook School, Whitehouse School or Three Bridges School.
- 3. The program needs to be run and/or supervised by a current employee of the Readington Board of Education during the 2021-22 school year.
- 4. The program must be outside of the everyday classroom curriculum. It may be inclusive of specials, enrichment programs, clubs, after school activities, and/or short-term programs.

RECOMMENDATION PROCEDURES

- 1. A recommendation may be submitted in writing, to the H.S.A. Executive Committee, regarding your choice for the Program Recognition recipient via email. The letter should not exceed one page. It should state the program, the staff member(s) in charge and the reasons for recommendation.
- 2. The recommendation must be received by the H.S.A. Executive Committee no less than 2 weeks prior to the May Business Meeting or as otherwise may be directed by the President of the H.S.A. **Deadline is April 14, 2022 this year.**
- 3. The recommendation will be reviewed by the H.S.A. Executive Committee prior to the May Business Meeting.
- 4. The H.S.A. Executive Committee will decide on one candidate for the district and will present its choice to the Board of Trustees at the May Business Meeting.
- 5. At the May Business Meeting, a motion will be made to accept the Executive Committee's candidate. If no motion is passed, there will be no award presented that school calendar year.

PRESENTATION OF THE AWARD

1. The program winner will be awarded with \$250.00 to be used towards the recognized program. The winner(s) will be presented with the award after the May Business Meeting once approved by the Board of Trustees.
