**WHEREAS**, said employee has an individual employment contract with a fifteen (15) days' notice provision; and

**WHEREAS**, the Superintendent has recommended that the Board invoke the fifteen (15) days' notice provision to terminate said employee's individual employment contract; and

**WHEREAS**, the Board has considered all of the evidence, including the record below and has determined that there are good and sufficient grounds to terminate the employee pursuant to the fifteen (15) day notice provision contained in the employee's individual employment contract.

NOW, THEREFORE, BE IT RESOLVED that the Board of Education hereby invokes the fifteen (15) days' notice provision of the above referenced

employee's individual employment contract, which notice shall be effective January 17, 2018; and

**BE IT FURTHER RESOLVED** that the Board shall continue the suspension of the employee with pay until January 17, 2018, the effective date of termination; and

**BE IT FURTHER RESOLVED** that the Board Secretary/Business Administrator shall provide the employee with notice of the Board's action as set forth in this Resolution forthwith.
