As you are aware, bids were received on April 21, 2020, for the above referenced project. There was a total of thirteen plan holders and ten (10) contractors submitted a bid for the project; a copy of the bid tabulation is attached hereto for your reference.

The scope of work for this project consists of approximately 10,000 s.f. of roof replacement with new modified asphalt built-up roofing. Areas of flashing replacement and masonry restoration are included.

At the time of bidding, the apparent low bid was received by **Pravco, Inc.**, of Rahway, NJ, in the base bid plus alternate bid in the amount of \$398,314.00. At the time of review, the subcontractor's Contractor Registration Certificate included was expired but we were able to independently verify it is current with the state at the time of bidding. We also understand that the price is within the Board's available budget for the work.

Therefore, based on the above, and pending concurrence from the Board's legal counsel, SSP makes the following recommendation:
