Dear Ms. Kenderdine:

Pursuant to your request we are pleased to submit this proposal for preparation of a metes and bounds legal description for dedication of a Sight Easement at the driveway entrance to the school off of Readington Road (C.R. 620). As you may be aware, Van Cleef Engineering Associates (VCEA) previously prepared Site Plans for improvements to the Intermediate School in June 1997. Based upon a review of available aerial photography, it appears that the access driveway was constructed in the location as shown on the site plans.

The scope of work is more particularly outlined as follows.

SCOPE OF WORK

VCEA will prepare a metes and bounds legal description of the sight easements situated on each side of the access driveway. The description will be tied to the property line and follow the right of way line of Readington Road as previously dedicated and shown on the Site Plan.

The Fee for this task is \$350.00.

If the Board feels that the access driveway was not constructed as designed or wants to verify the location of same before preparing the legal descriptions, VCEA will send a field crew to the site and locate the driveway entrance. Once this has been completed the sight easement descriptions can be prepared with the driveway situated properly within the easement.

The Fee for this task is \$400.00. This fee does not include the fee for the legal description, which is an additional \$350.00 as described above.

The Board attorney will utilize the legal description prepared by VCEA and prepare the deed of dedication to the County.
