Funding from this grant would allow the Energy Efficiency Program at Readington Township Schools to advance to the next level. The behavior based program that is currently in place in the district has resulted in annual energy usage reductions greater than 10% for the

past three years. The district's four schools are currently only metered at the building utility supplies. As a result, the buildings are black boxes as far as energy usage particularly for electricity since so many devices in the buildings use electricity as an energy source. Installation of Panoramic Power's wireless sensors and the associated cloud based dashboard will allow us to visualize real time device level data on how equipment in the school buildings are using electricity. This will allow the Facilities Department and Energy Efficiency Coordinator to understand equipment usage, identify opportunities for energy conservation efforts, and to move toward more predictive maintenance. Additionally, the information collected can be shared with staff to increase energy awareness and with students for energy education. The Panoramic Power program is designed to work with the National Energy Education Development (NEED) program's energy kits for energy education. Thanks to previous grant funding, we already have NEED energy kits available at each school as part of mobile energy labs. Advancing the Energy Efficiency Program, continuing energy awareness efforts, and increasing opportunities for energy education are initiatives supported by the district's Green Committee and will allow us to conserve energy and reduce our carbon footprint.

Grant funds will be used to contract with Direct Energy Business for the design, installation, and monitoring of the Panoramic Core package which includes 100 wireless electrical power sensors and associated hardware (see quote attached). The sensors will be deployed throughout the district's schools with the objective of assessing device level electricity usage. Panoramic Power includes a cloud based program to analyze data from the sensors and a dashboard to view the data along with customizable electricity usage reports. Remaining funds needed will come from the school budget.

#### f. Evaluation

The success of the Power Monitoring Program will be measured as part of our ongoing energy tracking program where the Energy Efficiency Coordinator reviews energy cost and usage in the district each quarter. We will track the implementation of energy savings opportunities identified as part of the device level monitoring provided through the Panoramic Power program and correlate if possible to electricity usage in the building using EnergyManager software.
