## **Minutes**

## 1. Reopening

- a. Reviewed Presentation Draft
  - i. Sept 3rd and 4th will be student half days split A/B, in-person only. Time allotted in afternoon for teacher PD and meeting with virtual students
  - ii. Monday, Tuesday A day, Wednesday virtual, Thursday, Friday B day (allows for additional Wednesday cleaning, consistent with high school)
  - iii. Wednesday can be virtual for teachers if desired
  - iv. ESL, IEP 4 day in-person self-contained classes will be offered; parents of eligible students will be notified
  - v. Masks will be required unless you are told to remove; breaks will be given throughout the
  - vi. Wellness/Mental Health check-ins on live days; morning meetings on Wednesdays
  - vii. Instruction for each class begins with a 15-20 minute mini-lesson
  - viii. Teachers will have chromebooks, bluetooth headsets, and Epson whiteboards
    - ix. K and 1st grade appointments with teachers to teach how to use the software and chromebooks
    - x. Jim Belske provided a sample instruction of what the google meet will be like for virtual students
      - 1. If we are required to go fully virtual, there are plans in place to teach students in the first weeks of school how to use SmartSuite and other software tools to share screens to be more interactive
  - xi. Pre-assessments to understand what gaps in education there may be from last year to this year; lessons to address those gaps would be tailored as needed. Intervention programs will continue
