



# **HIB Self Assessment Results 2022-2023**

## **Process for Determining and Submitting Scores**

- School Climate Team led by School Counselor and/or Principal completes the self assessment
- Building results are reported to Anti-Bullying Coordinator
- Data is compiled and presented to Board of Education upon approval from building principals and the Anti-Bullying Specialists
- Self Assessment results are entered onto the NJDOE website for final submission
- Official release of grade report is posted on the district's website once made available by the state.




# Self Assessment Scoring Rubric

## 8 Core Elements:

- HIB Programs, Approaches or Other Initiatives
- Training on the BOE-approved HIB Policy
- Other Staff Instruction and Training Programs
- Curriculum and Instruction on HIB and Related Information and Skills
- HIB Personnel
- School-Level HIB Incident Reporting Procedure
- HIB Investigation Procedure
- HIB Reporting

\*There are indicators within each core element.  
There are a total of **26 indicators**.




## **Grading Scale for Each Indicator within each Core Element:**

- 0-Does Not Meet the Requirements
- 1- Partially Meets the Requirements
- 2-Meets All Requirements
- 3-Exceeds Requirements

**Highest Possible Score is 78.**

*Note: If a school met all requirements and received a 2 (meets all requirements) for every indicator, their final score would be a 52.*





### HIB Programs, Approaches, or other initiatives


- Administer the NJ School Climate Survey to annually assess HIB programs, approaches or other initiatives.

- Develop and provide training on HIB policy for contracted service providers and volunteers.



### Curriculum and Instruction on HIB and Related Information and Skills:


- Provide ongoing age-appropriate instruction on preventing HIB


