

School Based Services Contract

For contract period August 23, 2021 through June 30, 2023, , Hunterdon Behavioral Health, 2100 Wescott Dr. Flemington NJ 08822, (hereafter known as HBH) agrees to provide School Based Services to Readington Middle School, at 48 Readington Road, Whitehouse Station, NJ at a cost of \$100,000.00.

Hunterdon Behavioral Health further agrees to provide the following services through the School Based Program:

Services will be provided for three days per week for the contract period excluding paid time off and holidays.

The School Based Initiatives (**SBI**) program provides a variety of intervention services to youth at risk who attend school at a designated school based site. Services are provided to youth who struggle to manage emotional and behavioral issues that impede their healthy function in school and/or in the community, as well as those who might benefit from preventative interventions and strategies. School based therapists will work with Hunterdon Behavioral Health and community based organizations in order to facilitate linkages, coordinate treatment and develop services necessary to address the problems encountered by youth and their families. Services are provided on-site in the school for easy access. Services include:

- Assessment and referral services
- Case Management services
- Supportive Counseling; individual, family, group and crisis services
- Socialization programming; group activities include year round events such as trips and summer program

SBI serves the needs of clients and their families by providing direct services, referrals and linkages to existing community programs, and through community education and outreach. The program is designed to provide easy access and linkages to a broad spectrum of mental and physical health services, as well as recreational services. SBI provides “one stop shopping” for students including individual/group services in the following areas:

- Preventative health
- Learning support
- Substance abuse education
- Pregnancy prevention
- Medical referrals
- Recreation and Transportation
- Mental Health
- Classroom presentations to address timely topics as requested by the school

School Based Services will be **invoiced** upon return of this contract with option to pay quarterly, bi-annually or year in full.

Modifications or terminations of this contract can be made by either party, in writing, with 30 days advance notice if occurring prior to the anniversary date of the contract. Examples of modifications include expansion of services requested, and/or termination of contract. If contract is terminated before one year, the parties may not enter into a new agreement during the first year of the original term of agreement.

Both parties shall defend, **indemnify and hold harmless** the other, its officers, employees and volunteers from any and all claims, injuries, damages, losses or suits including attorney fees, arising out of or resulting from acts, errors or omissions of one another in the performance of this agreement.
