

## ADDENDUM NO. 1 TO SHARED SERVICES AGREEMENT

This **Addendum**, made this 1st day of September, 2021, by and between **Tewksbury Board of Education**, with administrative offices located at 173 Old Turnpike Road, Califon, New Jersey, (hereinafter referred to as the "Tewksbury") and the **Readington Township Board of Education**, with offices located at P.O. Box 807, Whitehouse Station, New Jersey 08889 (hereinafter referred to as the "Readington") (hereinafter collectively referred to as the "Parties").

### WITNESSETH:

**WHEREAS**, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et. seq., authorizes local units of government to enter into such arrangements;

**WHEREAS**, the Tewksbury and Readington are parties to a Shared Services Agreement entered into in April 2021 (hereinafter referred to as "the Agreement"), relating to combined pupil transportation operations; and

**WHEREAS**, the parties have determined that it is in their best interests to continue the above referenced services; and

**WHEREAS**, the parties are desirous of memorializing changes to the Agreement;

**NOW THEREFORE**, it is hereby agreed by and between the parties that sections of Articles 2 and 4 of the Agreement shall be amended to read as follows:

**"2. Costs.** The total costs of the technology support services shall be \$147,613 for the 2021-22 school year, to be paid on a monthly basis in accordance with Article 4 of this Agreement."

and

**"4. Payment Procedures.** Tewksbury shall remit payment of 1/10 of the annual sum to Readington on a monthly basis \$14,761.30 per month during the 2021-22 school year, Tewksbury shall reimburse Readington no later than five (5) business days after its monthly meeting. Should Tewksbury request additional services not covered in the flat monthly rate, pursuant to Article 1, B. 8. above, Readington shall for such extra costs, and Tewksbury shall remit payment of said voucher no later than five (5) business days after the monthly meeting in which the voucher is approved."

**It Is Further Agreed**, by and between the parties, that all other terms and conditions set forth in the Agreement and not specifically addressed in this Addendum No. 1 shall remain in full force and effect.
