Dear Mr. Andrew Prior,

In December 2018, the Readington Township Board of Education and Republic Services of New Jersey, LLC entered into a contractual arrangement for refuse disposal and recycling collection services. The contract and bid for these services included a clause to extend the agreement for up to two (2) additional one (1) year extensions in accordance with N.J.S.A. 18:18-42. Language in the bid specifications stated the following:

*The terms and conditions of the extension shall remain substantially the same as in the original contract, the contract shall be awarded by resolution of the Board upon its finding that the services are being performed in an effective and efficient manner, and that the price change, if any, not exceed the change in the index rate as defined by N.J.S.A. 18A:18A-2(bb).*

On October 20, 2021, the Business Administrator, the acting purchasing agent of the Readington Township Board of Education and Republic Services of New Jersey, LLC agreed to a one (1) year extension from January 1, 2022 through December 31, 2022 with an increase at a rate of four (4) percent over the amount in the bid for the period of January 1, 2021 through December 31, 2021, which was \$61,504.35. The new amount for 2022 therefore shall be \$63,964.52.

The Readington Board of Education shall hold a board meeting on Tuesday, November 9, 2021 to vote on this extension at the stated amount above with all other terms and conditions of the original contract remaining substantially the same.

If agreeable to both parties, the below signatures shall effectuate.
